- That employers provide and maintain a working environment that is safe and without risk
- That employees take reasonable care for the health and safety of themselves and others

JOB TASK ANALYSIS

Job Task Analysis identifies the content of a job in terms of activities involved and attributes or physical requirements needed to perform the activities. Job Task Analysis reports provide information to organisations which help to determine which employees are best fit for specific jobs and to identify appropriate work to provide when a worker is injured.

Through Job Task Analysis, we determine what the important tasks of the job are, how they are carried out, and the necessary physical & psychological qualities needed to complete the job successfully. They can be used as part of:

DRUG & ALCOHOL SCREENING

Having a robust drug and alcohol policy is absolutely key to the effective management of alcohol and other drugs in the workplace. Workplace drug and alcohol testing ensures that workers are safe at work and not impaired by the effects of alcohol or drugs; whether those drugs are illicit, prescribed or over the counter.

Applications include:

- Pre-employment screening
- Rapid response 24/7 onsite post incident testing (including roadside)
- For cause / reasonable suspicion testing
- Onsite testing including random selection vs blanket selection of up to 200 workers

Testing according to the Australian Standard includes:

- Oral fluid drug testing
- Urine drug testing
- Alcohol breath testing

We utilise NATA accredited laboratories to ensure the fastest possible turnaround of results and are able to provide confirmatory drug results often the same day samples are received.
